REGARDING CONSUMER REPORT  
CALIFORNIA

In processing your application for employment or for other employment purposes, Anchor Blue, Inc. may procure an investigative consumer report (as defined by California but not Federal law) on you. The information to be obtained by Anchor Blue, Inc. is for employment purposes only, may include information regarding your character, general reputation, personal characteristics and mode of living, and may be shared with Anchor Blue, Inc. affiliates. If you do not wish the information to be communicated to such affiliates, you must notify Anchor Blue Inc. in writing.

**The investigation will be conducted by Asset Control, 1300 Fulton Place, Suite 300, Denton, Texas 76201, (940) 891-1919, a consumer reporting agency. Anchor Blue, Inc. will provide you with a copy of the report within three (3) business days after Anchor Blue, Inc. receives the report.**

The nature and scope of the investigation will be limited to a criminal background check. Section 1786.22 of the California Civil Code gives you certain rights with respect to the information retained by the consumer reporting agency, including your right to inspect your file, have your file explained to you by trained personnel, and to have another individual with you when you inspect your file.
